CAT CAIS LTID Reporting Certification

- Any continued Production Readiness Certifications for LTID are to be completed in the Prod Mirror environment.
- Registration for CAIS LTID requires Reporters to indicate their approximate number of FDIDs that have associated LTIDs.
- For Reporting Agents, this should be the aggregate total of all FDIDs with associated LTIDs.
- Only Reporters and Reporting Agents that pass certification will be able to submit data into the Production environment.

Full CAIS Phase Reporting Certification

- Full CAIS Phase certification will open in the Industry Test environment on February 1.
- Webinar from October 6, 2021, covered Full CAIS certification requirements and is available on the [CAT NMS Plan site](#).

- Only Reporters and Reporting Agents that pass certification will be able to submit data into the Production environment when it opens on April 25.
